**TERMS OF AGREEMENT**

1. Customer agrees to pay the following amount:

2. Total amount of the rental fee must be paid in full in advance (at the time the rental of Thrall’s Opera House is scheduled).

3. Customer is responsible, and agrees to pay “New Harmony Artists Guild,” for all repairs due to damage beyond normal wear, caused by negligence, alterations, or any other reason. Should the instrument be damaged beyond repair, customer agrees to pay “New Harmony Artists Guild” the then current retail price of the instrument.

4. “New Harmony Artists Guild shall not be responsible for any legal fees associated with music played on its instrument by other parties. The Renter shall assume all licensing fees and filings.

5. No abusive playing is allowed on the instrument.

6. No one is permitted to place any object on the above mentioned 8' Steinway E, Serial #141186. Said objects consists of, but are not limited to, the examples listed below:

- a. No liquid of any kind is allowed to be placed on this instrument.
- b. No candles (lit or unlit) are allowed to be placed on this instrument.
- c. No pictures, candelabras or containers of any kind are allowed to be placed on the instrument.
- d. No flower arrangements, or decorations of any kind are allowed to be placed on this instrument.
- e. No other musical instruments are allowed to be placed on top of this instrument.

7. No one may attempt to repair, maintain, or work on this instrument other than persons authorized by "New Harmony Artists Guild".

8. No one may move this instrument from its location, from within the building or upon the stage, except persons authorized by "New Harmony Artists Guild".

9. "New Harmony Artists Guild" will make the determination and have the final say as to who has permission to rent the Corbin Heintl piano which is housed in Thrall's Opera House.

10. No verbal promises are binding unless set forth in writing in this agreement. Neither the customer, representatives of Thrall's Opera House, "New Harmony Artists Guild", or any other entity may change any of the terms of this agreement unless all parties sign the changes.
